SUBJECT: *IRB Capital Improvement Plan 2025-2029*

This memorandum provides a summary of the proposed Five-Year Capital Improvement Plan for FY 2025-2029. The detailed CIP is attached for your review.

The Capital Improvement Fund utilizes revenues from the Penny for Pinellas, SWFWMD Grants, Gulf Boulevard Penny Fund, the American Rescue Plan and General Fund Unassigned Reserves transfer.

CAPITAL IMPROVEMENT PLAN SUMMARY

Roadway Milling, Resurfacing, Curbing & Drainage

Concrete curb, base rehabilitation, and/or new asphalt surfacing and associated drainage for each of the five years. This continued designation of funds represents the City's commitment to maintain and enhance this major City asset. In 2022, the City's comprehensive stormwater plan was updated. The update is used to guide the development of future drainage enhancement projects, ensure compliance with the unfunded mandates as part of Florida House Bill 53.

Stormwater Reconstruction

Reconstruction of basin stormwater collection and discharge facilities as required by NPDES. Half of the cost of this project will be covered by SWFWMD grants and is scheduled for 2026.

The plan includes a drainage project referred to as Harbor Drive North Outfall #2. The total project cost is \$600,000. The City will request \$480,000 from the State of Florida. Funding from the State will dictate the completion of this project.

City Park Upgrades

In 2025 the Plan provides for:

- \$815,000,00 allocated for the final year of multiyear rehab of the IRB Nature Preserve Boardwalk. Wood decking and railing will be replaced with recycled composite material. In addition, support repair will be completed.
- \$41,000 Brown Park Swing Shade
- \$65,000 Kolb Park Irrigation & Sod
- \$50,000 Christmas Tree
- \$110,000 Replacement of existing lighting and the installation of LED Lighting in Kolb Park at the Skatepark, Basketball Court & Tennis Court.

Gulf Boulevard Undergrounding Phase II

This project will be completed by the end of 2025 and includes the undergrounding of utilities along Gulf Boulevard from 5th Avenue to approximately 15th Avenue.
