

- 1. All occupants of short-term vacation rental units must comply with Chapter 26 of the City's Code of Ordinances (See QR below), governing parking, noise, nuisances, litter, and abandoned property.
- 2. All occupants must promptly evacuate the short-term vacation rental upon posting any evacuation order issued by state or local authorities. For reference, you are in **Evacuation Zone A**. Please see the evacuation map for directions. You may also visit

pinellas.gov/topic/safety-emergencies/ for further information.

- **3.** You are vacationing in a residential area, please be mindful of all noise during all hours. Quiet hours are from 10 pm to 7 am daily and you must adhere to the local noise ordinance.
- **4.** Maximum occupancy in IRB residential areas is 2 guests per bedroom with a maximum total of 12 guests. This is set to begin tentatively in early 2025.





PARKING DIAGRAM:




MAIN DRIVEWAY PARKING FOR 4 CARS

LAULES & INFORMATION

- 1. All occupants of short-term vacation rental must comply with City's Code of Ordinance regarding litter, noise, parking, trash, and sea turtles.
- 2. Be respectful of the property, its furnishing, and amenities. This mean taking care of the furniture, appliances, and other items in or on the rental property. Do not damage anything, and report any problems to the host immediately.
- 3. NO SMOKING, NO VAPING
- 4. NO PETS

5. QUIET HOURS 10 PM - 7 AM

You are vacationing in a residential area. Please be a good neighbor by keeping the noise to respectful level during the day and night. Excessive and unreasonable noise can deprive neighbors of the peaceful enjoyment of their property.

6. TRASH

7. PARKING

Four (4) total parking spaces are available, two (2) in the driveway, and two (2) additional on the front of the property on the pebble river gravel. 8. OCCUPANCY

Occupancy of short-term rental units is base on the number of bedrooms and beds. Our 2 bedrooms house allows up to 5 persons. It is non-Negotiable.

IRB Beaches are home to Sea Turtles. The City prohibits shining lights on the turtles at night. All sand structures and holes created on the beach must be returned to natural beach form.



Turtle Nesting Season

TURTLE NESTING SEASON

The Florida marine turtle nesting season is from May to October each year.

There are seven species of sea turtles including the green turtle, hawksbill, leatherback, loggerhead, olive ridley, Kemp's ridley and flatback. All but the olive ridley and flatback are found in Florida. Females nest every two or three years during the summer when they crawl to the shore to dig a nest in the sand using their rear fins. The female deposits about 100 eggs the size of ping pong balls in the nest. She covers the eggs with sand when she's finished and returns to the ocean. Male sea turtles never return to the shore after hatching. Only 1 in 1,000 hatchlings will survive to adulthood.

There are simple steps everyone can take to help protect marine turtles such as:

- Not leaving objects on the beach overnight
- Knocking down sandcastles and filling in holes before leaving the beach
- Placing all trash and recyclables in the proper containers
- Drawing the curtains at night to keep light from being seen from the beach
- Shielding all exterior lighting, using the least amount of lighting necessary, keeping lights low to the ground, and using long-wavelength (amber) bulbs. If you live or stay within view of the Gulf, be sure to turn off the lights inside your house when you leave and keep your curtains drawn when you are home. Also, make sure any exterior lights visible from the beach are turtle compliant. Do not use flashlights or cellphones on the beach at night.
- The Florida Fish and Wildlife Conservation Commission (FWC) keeps an updated list of best management practices for marine turtle lighting.

 Call the FWC Wildlife Alert number at 1-888-404-FWCC (3922) to report:
- Stranded hatchlings
- Harassment of sea turtles
- Disturbance of nests
- Entangled sea turtles
- Disoriented hatchlings
- Dead or injured sea turtles or hatchlings






HOW TO SPOT A RIP CURRENT




House Escape Route



Make sure you can get out of your home quickly if there is a fire.

The best fire escape plan is worthless if your escape route is blocked. White deadlocks and security grilles deter thieves, they can be deadly in a fire When you are in the house:

- Leave keys in any deadlock, or on a hook close to the door or window, but out of reach of intruders.
- Make sure that window security grilles and screens open readily from the inside.
- Make sure that all windows and doors open easily for all members of your family.
