The following cases were heard:

### A. CASE NO. 2001024751 - BLUE DREAM MANAGEMENT LLC

2115 1ST ST (6 UNITS)

**Violation:** IRB MUNICIPAL CODE Sec. 18-204

**Respondent Present:** Yes - Vadim Carter (Managing Member)

**Orders:** Case CONTINUED to March 12, 2026, at 2:30 PM. Magistrate requested City provide legal analysis of Magistrate's subpoena authority by February 27, 2026 (two weeks from hearing date). If City argues Magistrate lacks authority, respondent will have 4-5 days to respond.

Magistrate will rule on subpoena issue prior to March 12, 2026, hearing.

**Compliance Status:** Noncompliant as of February 2026

**B. CASE NO. 2001024752 - ANGEL FRANCO CRUZ**

**Violation:** IRB MUNICIPAL CODE Sec. 18-204

**Orders:** Property owner ordered to pay \$500 administrative costs and \$500 fine. Total: \$1,000. 10% discount available if paid within 24 hours.

**Compliance Status:** FULL COMPLIANCE achieved as of January 27, 2026; certificate valid until January 27, 2027.

**C. CASE NO. 2001024753 - ROBIN M ROBERTSON TRE, MARY M MCKNIGHT TRE, LORRAINE M TRAINA**

**Violation:** IRB MUNICIPAL CODE Sec. 18-204

**Orders:** Property owner ordered to pay \$500 administrative costs and \$500 fine. Total: \$1,000. 10% discount available if paid within 24 hours.

**Compliance Status:** IN COMPLIANCE as of hearing date.

**D. CASE NO. 2001024754 - NIHAIL & ATENA NISTOR**

1209 1ST ST

**Violation:** IRB MUNICIPAL CODE Sec. 18-204

**Action Taken:** Case WITHDRAWN by city for further review of international notice procedures.

**E. CASE NO. 2001024755 – STEVEN J. HOFFMAN & JEANINE A CARLSON**

732 BEACH TRAIL

**Violation:** IRB MUNICIPAL CODE Sec. 18-209

**Orders:** Property owner ordered to pay \$500 administrative costs and \$1,000 fine. Total: \$1,500. 10% discount available if paid within 24 hours.

**Compliance Status:** Not yet in compliance as of hearing date. Application submitted, fire inspection completed February 9, 2026. City inspection scheduled but not yet completed as of hearing date.

**F. CASE NO. 2001024756 - ROWENA M. JIMENEZ**

110 11TH AVE

**Violation:** IRB MUNICIPAL CODE Sec. 18-209

**Orders:** Property owner ordered to pay \$500 administrative costs and \$4,000 fine. Total: \$4,500. 10% discount available if paid within 24 hours.

**Compliance Status:** Nearly in compliance as of hearing date. Renewal application submitted and in process. Fire inspection completed. City inspection still needed to complete compliance.

## **G. CASE NO. 2001024757 - REBECCA A & THOMAS M RIEDER**

2702 BEACH TRL. UNIT B

**Violation:** IRB MUNICIPAL CODE Sec. 18-209

**Orders:** Property owner ordered to pay \$500 administrative costs and \$1,000 fine. Total: \$1,500.  
10% discount available if paid within 24 hours.

**Compliance Status:** FULL COMPLIANCE achieved as of February 12, 2026.
